FOOD BUSINESS ESTABLISHMENT**

(Regulation (EC) No. 852/2004 on the Hygiene of Foodstuffs, Article 6(2)) This form should be completed by food business operators in respect of new food business establishments and submitted to the relevant food authority 28 days before commencing food operations. On the basis of the activities carried out, certain food business establishments are required to be approved rather than registered. If you are unsure whether any aspect of your food operations would require your establishment to be approved, please contact The Council of the Isles of Scilly for guidance.

NOTES ON REGISTRATION OF FOOD BUSINESS ESTABLISHMENTS

What is registration?

1. Registration of food business establishments (including market stalls, domestic premises used as a food business, delivery vehicles and other moveable structures) is required by law. Registration will allow local authorities to keep an up to date list of all those premises in their area so they can visit them when they need to. The frequency of the visits will depend on the type of business.

Who needs to register?

2. If you run a food business, you must tell (or arrange for someone else to tell) the local authority about any premises you use for storing, selling, distributing or preparing food. Food premises includes restaurants, hotels, cafes, shops, supermarkets, staff canteens, kitchens in offices, warehouses, guest houses, delivery vehicles, buffet cars on trains, market and other stalls, hot dog and ice cream vans etc.
3. If you use vehicles for your food business in connection with permanent premises such as a shop, or warehouse you only need to tell the local authority how many vehicles you have. You do not need to register each vehicle separately. If you have one or more vehicles but no permanent premises, you must tell the authority where they are normally kept.
4. Anyone starting a new food business must register with the local authority at least 28 days before doing so.
5. The majority of food business establishments will have to be registered. However, certain food businesses premises are exempt from registration eg those which require approval under Regulation 853/2004. You should contact your local authority if you think you might be exempt.

How do I register?

6. By filling in this form. Registration cannot be refused and there is no charge. The registration form must be sent to your local authority. The address can be found in the telephone directory. If the form is sent to the wrong address your application will not take effect until it is received at the proper place. If you use the premises in more than one local authority area, you must register with each authority separately.
7. You must tick all the boxes which apply to your business, answer all the questions and give all the information requested. Seasonal businesses operating for a certain period each year should give the dates between which they will be open in answer to question 7. If you have any questions your local authority will help you. It is an offence to give information which you know is false.

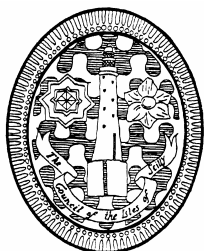
What happens to the information given on the form?

8. The local authority will enter the details on its Register. A register of addresses and the type of businesses carried on at each will be open to inspection by the general public. The register will include: (i) name of food business operator, (ii) name of food business (iii) address of food business establishment (iv) particulars and nature of the food business.

Changes

9. Once you have registered with the Local Authority you only need notify them of a change of proprietor, if the nature of the business changes, or if there is a change of the address at which moveable premises are kept. The new proprietor will have to complete a new food registration form.

If the local authority wishes to change the entry in the Register because of the information which it receives from someone else you will be given 28 days notice and an opportunity to comment on the proposed change.
