# Level 2 Fire Safety



This e-learning course is ideal for anyone looking to achieve a Fire Safety Level 2 qualification. This course is suitable for all those involved with fire safety in the workplace. This includes managers, supervisors, team leaders, fire wardens (marshals) and staff working in any area where there is a potential risk of fire

There are a total of 4 training modules included in this course cover the key syllabus of Level 2 fire safety qualifications. Each module has a total of 5 multiple questions at the end to test learner knowledge. These modules include:

- Introduction to fire safety;
- The characteristics of fire;
- Fire safety legislation; and
- Assessing and managing risk

Learners taking this course will recognise that fire safety is the responsibility of everyone in the workplace and will recognise the consequences of a fire in any premises. On completion of this course, the system produces a personalised HABC commended certificate for the learner. They can then upgrade this to an accredited qualification by sitting an exam if required



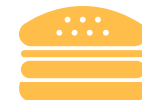
# Level 2 Health & Safety



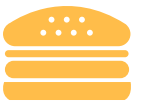
The Level 2 Course has been devised to meet the legal basic requirements for all people in the workplace. Every employer legally should provide Health and Safety training for their employees under the Health and Safety at Work etc Act 1974. E-learning is great way to meet that legal responsibility very quickly and effectively. The course includes the following:

- Introduction to health and safety
- Accidents including slips, trips and falls
- Risk assessment
- Workplace health, safety and welfare
- Work equipment safety
- Fire safety
- First aid arrangements
- Manual handling
- Hazardous substances (COSHH)

- HACCP from deliver to service
- Refrigeration, chilling and cold storage
- Taking temperatures
- Cooking, hot holding and re-heating
- Reducing the risk of contamination
- Personal hygiene
- Cleaning and contamination
- Food premises and equipment
- Food Safety and Enforcement

# Level 2 Personal Licence
