INTRODUCTION

<u>Purpose:</u> The Fire and Rescue Service's (FRS) Integrated Risk Management Plan (IRMP) is to provide direction, focus, objectives and aims for the FRS to deliver upon allowing it to work toward our agreed vision "to maintain and sustain the Isles of Scilly as the safest community in which to live, work or visit".

The Action Plan is generated by the Fire and Rescue Authority's desire to maintain a high level of service and to improve that service. The IRMP provides the basis and drive for improvement which is available from our website www.scilly.gov.uk. The Council of the Isles of Scilly provides an over arching strategic plan which the IRMP services.

The Action Plan evolves on an annual basis driven by many influences including recommendations following audit, assessment and review, consultation with staff, elected members and the public. National, regional and local influences including new legislation, regulation or identified best practice also play a part.

Each action is assessed for impact in respect of resources and cost to ensure it is affordable. A responsible person and deadlines are identified for monitoring purposes. Progress is reported to the elected members of the Council forming the General Purposes Committee at their regular meetings.

The actions are grouped in to three service delivery areas.

FIRE SAFETY

The Fire Safety function, with support from all FRS personnel, co-ordinates effective fire safety advice and education to the general public, business community and visitors to the Isles of Scilly. The purpose of which is to reduce the number of fire related deaths, injuries and property damage.

The function also discharges by inspection and report, the statutory fire safety functions of the Fire Authority. These include the Fire and Rescue Service Act 2004, the Regulatory Reform (Fire Safety) Order 2005 and other legislation where a statutory duty to consult the Fire Authority is imposed.
