Extend the existing shed on its north elevation by continuing with the same roof pitch to a new timber frame hit and miss wall (matching the existing shed). The west elevation end wall will comprise an existing granite drystone wall infilled at the top with timber frame and hit and miss. The east elevation will comprise an open doorway against the existing shed and the remainder closed by timber frame and hit and miss.

The floor will comprise the existing concrete slab extending from the shed and existing compacted, crushed fine stone.

Slate grey powder-coated galvanised steel roof sheets matching the existing shed will be used.
