CONDITIONS

1. Suitable and sufficient warning signs are to be erected in advance of and at the site.
2. The area in question is to have barriers in order to prevent danger to pedestrians and vehicles
3. The area is to be properly lit at night.
4. The applicant must make formal contact with the following agencies to ensure the work does not impede their access. Where this agreement cannot be reached the Council will assist to find a solution but will be under no obligation to provide alternative arrangements. **Police, Fire Brigade, and Ambulance Service.**
5. This permission shall be operative for a specified period and at the end of that period the site is left in a clean and tidy condition and any damage to the Highway repaired to the satisfaction of the Senior Manager for Infrastructure & Planning or their representative.
6. Reportable incidents or accidents required under the Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995 (RIDDOR) are notified to the Council or Health and Safety Executive without delay.
