This document has been compiled from the minute books held in the council archives.

Dates in brackets are the dates of meetings at which an event was recorded. For example, 'Elected (6 May 1897)' means the earliest evidence provided in the records that a person has been elected may be found in minutes of a meeting on 6 May 1897. It does not mean the election took place on that date.

Dates without brackets are dates that an event took place.

It is not uncommon for members to be listed in the minute books with their initials only. In such cases, other sources have been used (e.g. Scillonian Magazine, census records, electoral registers) with a view to establishing the forenames. Judgements have sometimes been made in this regard.

Where a member is known to have used their middle name, it is this name rather than their first name that is given in full (e.g. H Roy Duncan rather than Harry R Duncan).

There was a convention, which remained intact until 1949, that one of the four aldermen should be an off islander. The island of residence for aldermen from the off islands is recorded here in brackets (although aldermen did not represent their particular island).

On 23 February 1918 the Local Government Board issued an Order extending the wartime provisions contained in the Parliament and Local Elections (No.2) Act 1917 and the Elections and Registration Act 1915 to the Isles of Scilly. Consequently the local election scheduled for 1918 was postponed by one year and casual vacancies were subsequently filled by the council rather than through a by-election.

In accordance with the Local Elections and Register of Elections (Temporary Provisions) Act 1939, all elections of councillors and aldermen were suspended. Existing councillors and aldermen were to continue in office and vacancies were to be filled by the council.

The Isles of Scilly Order 1943 determined that when Arthur A Dorrien Smith ceased to be chairman:

- the new chairman would be elected by the council; and
- the Duchy of Cornwall would be given the right to appoint a councillor.

In Nov 1943 the Land Steward of the Duchy of Cornwall was invited to attend all future council meetings. This invitation appears to have remained in place for the next 30 years.
