What will my information be used for?

The Council of the Isles of Scilly will use the feedback you provide, to inform any necessary changes required to the plans and progress made to date. The feedback will be shared in an anonymous format with the architects commissioned for the project to ensure the planning application captures the needs and views of the community.

Who else will we share your information with?

All comments and representations will be recorded at the Council Offices on St Mary's. To ensure the council can effectively and efficiently use your feedback to make required changes to our plans for the housing site; Ennor Farm, Old Town we will sometimes need to share your information between teams within the council as well as with third-partner organisations including, the architects commissioned for this project. If we consider it necessary to share your data with a third party organisation, outside of the Council, we will only do this in an anonymised format unless we have obtained your express further consent. All representations made in relation to this consultation may be published in an anonymised format on the Council's webpages.

How will my data be held?

Your data will be held within the Council of the Isles of Scilly secure network and premises and will not be processed outside of the EEA. Access to your information will only be made to authorised members of staff who are required to process it for the purposes outlined in this privacy notice.

How long will you keep this information for?

We will hold your person details for a period of 2 years following the end date of this consultation: 14th December 2020. Consultation responses, in an anonymised format, may be held for a longer period, to inform our application for planning permission or audit requirements.





What are my data rights?
