#### **Role Description**

##### **Purpose**

To contribute to the delivery of the Island Futures Strategic Economic Plan ( IF SEP ) by ensuring the delivery of the IF Key Coded Action Plan. Also to oversee the Isles of Scilly Voucher Scheme, evaluating project applications from local businesses. As Local Business representative you will be working closely with the stakeholder representatives from the Council of the Isles of Scilly, Duchy of Cornwall, Tresco Estate, Isles of Scilly Wildlife Trust, Cornwall and IOS LEP, Isles of Scilly Steamship Company, and Islands' Partnership.

##### **Principal Accountabilities**

To identify, articulate and prioritise delivery of the economic growth opportunities and tackle barriers to growth identified in the IF Key Coded Action Plan

To ensure public and private sectors are focused upon achieving IF SEP objectives through concentrating their main efforts on delivery.

To enable local business to grow by advising on the appraisal of eligible applications to the ERDF Voucher Scheme fund.
