Decision level of any other application will be decided once the planning department have considered the application which is usually towards the end of the statutory 3 week consultation period. These are therefore identified as 'delegated' [DEL].

If you consider your letter of representation to be of a confidential nature it must be clearly stated, but a request for confidentiality will mean that it may not be possible for your comments to be taken into account in the determination of the application.
