Notice is hereby given, in accordance with Regulation 22(3) of the Town and Country Planning (Local Planning) (England) Regulations 2012, that the Council of the Isles of Scilly submitted the Isles of Scilly Local Plan 2015-2030 Development Plan Document (DPD) to the Secretary of State for Housing Communities and Local Government on Monday 30th September 2019 for independent examination.

Subject Matter: the isles of Scilly Local Plan sets out the Council's planning framework for future development in the islands to 2030. It includes policies and proposals for development that will deliver the islands' housing and employment needs and address a range of key issues facing the community.

Area Covered: Whole of the Isles of Scilly.
