

Site and particulars of development: Harbourside Hotel, The Quay, St Mary's Amendments to fire escape staircase, installation of window at ground and first floor levels on South gable end, re-position first floor double doors on East facing balcony, replacement of 4 no. windows on West

elevation with one single window.

In pursuance of their powers under the above act, the Council hereby PERMIT the above works to be carried out in accordance with the following conditions:

C1 The works hereby permitted shall be begun before the expiration of three years from the date of this permission.

Reason: in accordance with the requirements of Section 18 of the Town and Country Planning Act 1990 and to ensure that the Local Planning Authority retains the right to review unimplemented consents.

C2 The development hereby permitted shall be carried out in complete accordance with the details shown on the approved submitted plans numbered 'T1033268.06 rev A' and 'T1033268.04 rev A' stamped and dated 19th August 2014.

Reason: For the avoidance of doubt and in the interests of the character and appearance of the listed building and the surrounding area, which is designated an AONB and Conservation Area in accordance with Policies 1 and 2 of the Local Plan.

C3 All external and internal works involving machinery required in connection with the implementation of this permission shall be restricted to between 0800 to 1800 hours Monday to Saturdays. There shall be no works involving machinery on a Sunday, Bank or Public Holiday.

Reason: In the interests of protecting the residential amenities of neighbouring properties.

1 Reasons for Approval for Listed Building Consent

Listed building consent should be granted as permitting the proposed works is not considered to conflict with the duty under Section 66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 to have regard to the desirability of preserving the listed building or its setting or any features of special architectural or historic interest which it possesses.
