REASON FOR WORKS: ALL TREES IN POOR CONDITION WITH LARGE AMOUNTS OF DEAD WOOD PRESENT. MANY ARE ALREADY SHOWING SIGNS OF WIND BLOW, POTENTIALLY ENDANGERING THE HOUSE, THE PUBLIC ROAD, THE STONE WALL BORDERING THE ROAD, THE ELECTRICITY CABLE TO THE WEST AND OTHER STRUCTURES AND BUILDINGS IN THE VICINITY. I AM A NPTC CERTIFIED ARBORIST WORKING TO BS3998 AND THERE ARE NO TREE SURGERY TECHNIQUES TO REMEDIATE OR RESJUVENATE THESE TREES. THERE IS A MATURE STAND OF ELM TREES TO SOUTH WHICH WILL MEAN VISUAL IMPACT OF THE WORKS IS NEGLIGIBLE.
