Dear Sirs,

We wish to make a Representation against Planning Application P/16/021.

Whilst no doubt the remodelling will improve the property, the increase in bulk and roof height will make the building more prominent when viewed from parts of St Mary's.

The Duchy of Cornwall has an exemption of the Garrison in the Leasehold Reform Acts, denying long residential leaseholders the right to enfranchisement. The basis of this exemption is that enfranchisement will be refused so as to safeguard the special/historic interest of the Garrison. There is no doubt whatsoever that the increase in roofline of 1.5m will have a visual impact on St Mary's and thus change the special/historic interest landscape of the Garrison.

The Duchy of Cornwall wants it both ways, preventing others acquiring the right to enfranchisement on the basis of special/historic interest, but at the same time, allowing itself to alter the special/historic interest landscape of the Garrison.

The Prince's Council requested the enfranchisement exemption from Ministers, this being granted without any consultation with those effected. This Planning Application demonstrates that control over the special/historic interest of the Garrison is in the hands of the Council of the Isles of Scilly and other bodies and not the Duchy, although the Duchy maintains otherwise.

Therefore, the application should be refused on the basis that the application is inconsistent with the 1967 Leasehold Reform Act, the 1993 Leasehold Reform Act and the Commonhold and Leasehold Act 2002 and the special and the unique exemption granted to the Duchy of Cornwall for the Garrison. The Leasehold Reform Acts were to provide social justice and to end feudal land tenure.

If the building is to be remodelled, then for natural justice and fairness to prevail, the work should be carried out within the existing roofline.
