environment and keep development to the minimum required for sustaining viable communities and to ensure those characteristics which contribute to the status of the Isles of Scilly as a Conservation Area, Area of Outstanding Natural Beauty and Heritage Coast are being protected. In accordance with the requirements of Policy 1 of the Isles of Scilly Local Plan 2005

- C 3 The development hereby permitted shall be carried out in accordance with the approved details only including:
 - 'Proposed Change of Use to mixed use salon/café' scale 1:50 dated 19th
 December 2016
 - 'Right Price PVCU Quotation 4489' dated 7th March 2017
 - 'Waste Management Plan' dated 7th March 2017

Reason: For the clarity and avoidance of doubt and in the interests of the character and appearance of the Listed Building and Conservation Areas, Area of Outstanding Natural Beauty and Heritage Coast in accordance with Policy 1 of the Isles of Scilly Local Plan 2005.
