Description of site and development:

This application proposes the replacement of the existing concrete wet laid slate roof to the front elevation of the property with a dry lay natural slate at Bristow, Bar, St Mary's.

Site Description

Bristow is located in the North of St Mary's. Bristow lies in an isolated location and is accessed via a farm track. Bar Farm lies at the top of the farm track. Bristow is a two storey dwelling of granite construction with a natural slate roof. The fenestration is painted timber. A single storey lean-to of matching materials lies to the north elevation and a porch of timber construction; timber framed glazing with a clay tile roof lies to the west elevation.

Description of Proposal

The proposed works include the replacement of the wet laid slate on the front elevation of the house with natural dry lay slates. The agent has confirmed that the proposed slate tile is a Brazilian slate, with dimensions of 500mm x 250mm, with a head lap of 100mm.

Background and Relevant History

There is no previous planning history for this property.

Public representations:

A site notice has been on display outside the site for a period of 21 days.

No letters of representation have been received.

Consultee representations:

A site notice has been on display outside the site for a period of 21 days. One letter of representation has been received.

Isles of Scilly Bat Group

The premises were visited on 30/10/17; conditions were fine day, cloudy with sunny intervals, dry, light breeze. Traditional Scillonian granite cottage; scantle slate tiles are in dangerous condition; there is a crack, owing to slippage, in the tiles for much of the length of the front roof and a small amount of concrete has been applied, *pro tem*, to prevent further slippage. The crack does not appear to be likely to admit bats. There is no access to the interior of the roof.

Bat Discovery Informative

Constraints and designations:

Conservation Area, AONB and Heritage Coast.

Relevant policies, SPGs and Government guidance:

Primary Legislation

The Planning (Listed Buildings and Conservation Area) Act 1990

The site is within a Conservation Area where there is a requirement to ensure that any development preserves or enhances the character or appearance of the area, as embodied in Section 72 of The Planning (Listed Buildings and Conservation Area) Act 1990.

The Countryside and Rights of Way Act 2000

The Isles of Scilly is also a designated Area of Outstanding Natural Beauty (AONB). The legal framework for such areas is provided by The Countryside and Rights of Way Act 2000. The Act places a statutory duty on the Local Authority to have regard to the purpose of conserving and enhancing the natural beauty of the AONB when exercising or performing any functions affecting land within it.

The Conservation of Habitats and Species Regulations 2010 (Consolidation of Conservation (Natural Habitats, &c.) Regulations 1994)

It is a legal duty of a Local Planning Authority, when determining a planning application for a development, to assess the impact on European Protected Species ("EPS"), such as bats, great crested newts, dormice or otters. A LPA failing to do so would be in breach of Regulation 3(4) of the 1994 Regulations which requires all public bodies to have regard to the requirements of the Habitats Directive in the exercise of their functions.

Planning Policy

National Planning Policy Framework (NPPF) 2012

At the heart of the NPPF is presumption in favour of sustainable development. The NPPF does not change the statutory status of the development plan as the starting point for decision making. Proposed development that accords with an up-to-date Local Plan should be approved and proposed development that conflicts should be refused unless other material consideration indicate otherwise. It is highly desirable that local planning authorities should have an up-to-date plan in place. With respect to general development and the Strategic Policies it is considered that the Local Plan remains up to date and conforms to the requirements of the NPPF.

Isles of Scilly Local Plan 2005

Policy 1 relates to environmental protection and seeks to permit development proposal only where they respect and protect the recognised quality of the island's natural, archaeological, historic and built environment. Proposals should (a) conserve or enhance the natural beauty, wildlife and cultural heritage of the Area of Outstanding Natural Beauty and protect the unspoilt character and good appearance of the heritage coast, (c) Preserve or enhance the character or appearance of the Conservation Area, (e) protect a statutorily protected plant or animal species and the wildlife, geographical and geomorphological interest and features of designated Sites of Special Scientific Interest; and locally important biodiversity habitats, species and landscape features.

Policy 2 relates to sustainable development and seeks to permit development where practicable and appropriate, proposals would contribute to the sustainability of the islands' environment, economy or local communities through: (a) conserving or enhancing the landscape, coastline, seascape and existing buildings of the islands through appropriate design including siting, layout, density, scale, external appearance (i.e. details and materials) and landscaping; (b) ensuring or

facilitating the re-use of previously developed land and existing buildings for the economic, social and environmental benefit of the islands and local communities taking into account any environmental designations set out in Policy 1.

Appraisal/key issues and conclusion:

In light of the above mentioned policies and identified designations it is considered that the principal issue for consideration is whether the impact of the proposed development is acceptable in relation to the principle of development, the materials, scale, design and appearance; the impact on neighbouring amenity and the wider Conservation Area.

The proposed works are to replace the existing wet laid slate roof covering with dry lay slate on the front elevation of the house. The existing slate is wet laid scantle with a 70mm head lap. The proposed slate is Brazilian, 500mm x 250mm, with a head lap of 100mm. The slates will be fixed using copper nails.

The agent has provided a site waste management plan. They state that the spoil arising from the project consists of timber lath, natural slate and lime mortar. The agent states that the masonry waste will be disposed of at Pendrethan Quarry where it will be crushed and recycled as hard core. Timber waste will be disposed of at Moorwell Waste Management Centre. All waste will be transported to the disposal sites by way of a licensed 3.5-ton tipper truck.

In relation to Policy 1(a) of the Isles of Scilly Local Plan 2005 the proposed works will not have an impact on the natural beauty, wildlife or cultural heritage of the AONB or the heritage coast. In relation to Policy 1 (c) the proposed works will preserve the character and appearance of the Conservation Area, through the removal of the existing natural slates and their replacement with natural slate. In relation to Policy 1 (e) the proposed works are unlikely to have an impact on protected wildlife or biodiversity habitats as indicated in the response from the Isles of Scilly Bat Group and the recommendations have been included as an informative in this report.

In relation to Policy 2 (a) of the Isles of Scilly Local Plan 2005 it is considered that the design and materials of the proposed works are appropriate and enhance the existing building. In relation to Policy 2 (c) it is considered that the proposed works to replace the existing natural slates with natural slate use natural resources efficiently in the design, construction and future use of land and buildings.

Impact upon the wider landscape.

Properties within this area are largely rendered white or a pale shade of stone with slate roofs and a mixture of materials on fenestration details. The proposed materials for the works match the materials on surrounding properties and it is judged that the use of these materials will pass the legislative test of preserving or enhancing the character and appearance of the Conservation Area.

The proposed site is visible from public vantage points but has no near neighbouring properties. There is existing planting that would help to screen the proposed works. It is judged that the proposed works would have no material impact on the Conservation Area or the wider landscape

due to its small size. The proposed works are to a dwelling and would be seen in context with existing residential dwellings and development.

The Isles of Scilly bat group have conducted a bat survey and advise that the existing tiles, which are to be replaced, lack any obvious openings for bat entry and there is no access to the interior of the roof. It is recommended that the standard cautionary bat informative be placed on any grants of planning permission. This advice will be included as an informative in the decision notice.

Impact upon privacy and amenity

The proposal is not considered to result in material harm to the privacy or amenity of adjacent residential properties or neighbouring land uses. The proposed works are to replace the existing natural slate roof covering with natural slate. It is considered that the proposed works would not cause any material increase in overlooking, be overbearing or cause any additional loss of light and it is therefore judged that the proposal is acceptable, in this case.

Conclusion

Drawing on all of the above considerations, it is considered that the proposal is acceptable and it is recommended for approval.

Recommendation:

Recommendation: The application be Conditionally Approved subject to the following Conditions:

- 1. The development hereby permitted shall be begun before the expiration of three years from the date of this permission.**

Reason: In accordance with the requirements of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990 (as amended).

- 2. The development hereby permitted, shall be carried out in accordance with the approved details only including:**

- The Location Plan – dated 09 August 2017**

These are signed and stamped as APPROVED

Reason: For the clarity and avoidance of doubt and in the interests of the character and appearance of the Conservation Area, Area of Outstanding Natural Beauty and Heritage Coast in accordance with Policy 1 of the Isles of Scilly Local Plan 2005.

- 3. The construction of the roof of the dwelling, hereby approved, shall be in accordance with the sample of natural slate submitted (Brazilian slates 500mm x 250mm) in support of the application and shall remain in accordance with the approved materials thereafter, unless otherwise agreed in writing by the Local Planning Authority.**

Reason: In the interest of visual amenity and the character and appearance of the development and to comply with Local Plan policy which requires the use of traditional materials.
