The Barn or Leah's Barn is located on New Lane, St. Agnes, Isles of Scilly.

The Barn is currently used as stage barn.

The walls are granite random style stone with cement fibre sheet roofing, the windows are of a traditional wood sash style. The main entrance door is a lattice and brace wood door there is also a double plywood panel door.

The surrounding boundary wall is constructed from granite stone.

The building is currently in a poor state of repair.

The proposed application is to re roof the existing building with natural slate tiles and refurbish or replace the existing sash windows as required and to re place the existing main door.

The proposed extension will measure 4.45m x 3.75m by 3.6m high. This extension is to be used a display area for the sale of hand made jewellery, but the applicant who is a local St. Agnes islander.

The proposed extension is to be clad with Hit and Miss boarding on the northern and eastern elevations which is a common material used on agricultural buildings on the islands, the south facing elevation will be mainly wooden windows on a small granite wall, with double wooden glazed entrance doors, painted white.

The roof covering will be Natural slate tiles to match the new roof on the main building.

The layout of the extension will be open plan to allow for visitor access to view the jewellery.

The main barn will also be open plan and be used as a work area.

Access to the display are will be from the main access road known as New Lane.

The Barn or Leah's Barn (Pic 1) is constructed from granite stone with fibre cement corrugated sheet roofing.

The Barn has a double wooden panel door made from plywood with a separate lattice and brace entrance door. The windows are wooden sash all of which are in a poor state of repair.

The Barn is currently used as a storage shed. There is not main electricity or water connected to the building.

The proposed application is to re roof the existing building with Natural Slate tiles and to add an extension onto the East Elevation, the proposed extension will be 4.45m x 3.75m by 3.6m high.

The proposed extension will be attached to the main building where the double doors are located.

The proposed extension is to be clad with Hit and Miss Boarding which is a common agricultural cladding and can be seem used on many building on St. Agnes and on other islands within the Isles of Scilly.

The roof will be Natural slate to match the main building.

Tamarisk Farm House is located to the north of the proposed extension and can be seen in Pic 2 on the right side of the image.
