# Lisa,

Please can the EA be consulted formally on this application?

I have some minor concerns about the appropriateness of the specified exemptions surrounding handling waste.

(Intended waste stream: Grass, hedge cuttings & general garden waste. Larger wood items to be chipped before composting)

**The D7 Burning waste in the open** exemption would not normally include waste brought to the site from elsewhere. Environmentally, the Council would not want any waste burned outside of the farms other existing business under

any existing exemption and would suggest that as a condition. **S2** storing waste in a secure place does not usually cover waste that will be disposed of BUT this is allowed Under U10 190599 for spreading on agricultural land: no problems

**T23 Aerobic Composting and Associated Prior Treatment** You can store or treat up to 80 tonnes of waste at any one time if you compost and use the waste in the same place it was produced. You can store or treat up to 60 tonnes of waste at any one time if you bring waste from other places to the place where it will be composted. I am told there will not be anywhere near even the 60 tonnes amount by Helen Pearce but perhaps the EA should confirm maximum allowed quantity for the Permission to reflect the legal amount.
