3. Description of Proposed Works (continued)

I propose to replace the existing external door which gives access to a passageway leading to my front door and garden, the property above my flat and access for Wingletang Guest House to the rear of my property.

The existing door is ill-fitting, in poor repair, swells in wet weather and allows rain under the bottom, resulting in flooding to the passageway and dampness to my lounge wall. Being solid, the door does not allow any light to the passageway or sight of any persons behind the door. On more than one occasion, whilst cleaning behind the door, I have been almost bowled over by persons entering.

I propose replacing the existing white painted door with a new white painted wooden door half glazed with either obscure or clear glass to allow both light into the passageway and give sight of any person behind the door.
