C3 All planting in the approved planting schedule shall be carried out within 28 days following the date of this decision notice. Any plants which within a period of 5 years from the completion of the development die, are removed or become seriously damaged or diseased shall be replaced in the next planting season with others of similar size and species.

Reason: To ensure the ducting is not a prolonged and visually harmful discordant feature that would be harmful to the wider character of the conservation area and setting of the quay as a

Grade II listed building, in accordance with Policy 1 of the Isles of Scilly Local Plan 2005.
