Roof

the existing flat roof coverings that require replacement vary from felt, asphalt and fibre-glass.

Description of proposed materials and finishes:

The proposals are to recover the existing flat roofs with a warm roof construction finished with a Carlisle single layer polymeric sheet roof covering. This will cause an increase in height of approximately 130mm.

Other type of material (e.g. guttering) Fascia and Soffits

The existing fascias and soffits are of timber construction.

Description of proposed materials and finishes:

The proposals are to replace the defective fascias and soffits and finish in a white PVCu horizontal shiplap style overcladding board.
