Thank you for your letter of 27 September 2018 regarding the above application for planning permission. On the basis of the information available to date, we offer the following advice to assist your authority in determining the application.

**Historic England Advice**

We welcome the inclusion of a Heritage Statement and the re-siting of the proposed site for the plant housing. We consider that whilst there will be an impact on the setting, and thereby significance of the three adjacent monuments, the existence of the current modern reservoir will to a large extent 'shield' that impact and the level of harm will be less than substantial.

The three Scheduled Monuments affected, however, 1013798 (round cairn 5m WSW of Vane Hill summit), 1014777 (round cairn 25m south west of Vane Hill summit) and, 1013799 (two platform cairns north east of Vane Hill summit), do derive a degree of significance from their setting around the summit of Vane Hill and the imposition of yet another modern structure within their midst will result in less than substantial harm to their setting.

To this end it would be to the applicants advantage to provide for some form of environmental enhancement in connection with the proposal, perhaps the removal of scrub from the monuments and their future maintenance under grass could be considered in the planning balance by your authority.

Finally, we recommend that you seek the advice of your specialist archaeological advisor regarding a suitable programme of archaeological intervention.
