Hi Hannah

Provisionally; we would recommend a 2<sup>nd</sup> emergence survey in mid-to late June. If the survey results suggest 'likely absence' then the report would be with you within 7-10 days after the final survey. So, I would say in this instance that the 1<sup>st</sup> week in July would be a sufficient extension.

If the survey results confirm presence then you could be looking at mid-winter i.e. December (to include an EPS license application) at the earliest. But this is a bridge that we can cross if it comes to that.
