Site: Land Adjacent to Council Workshop, Moorwell Lane, St Mary's, Isles of Scilly.

Proposal: Installation of electric vehicle charging points and solar canopy and creation of electric vehicle charging bays.

Comments: Possible access restrictions to workshop garages although thought unlikely.

Site: Land Adjacent to Ennor Close Garages, Old Town, St Mary's, Isles of Scilly.

Proposal: Installation of electric vehicle charging points, solar canopy and creation of electric vehicle charging bays.

Comments: Raised concerns regarding the loss of permanent parking spaces for residents and visitors forcing vehicles to park on the estates access roads. Loss of turning area for large/high-sided vehicles (deliveries) due to canopy.

Site: Land Opposite Police Station, Garrison Lane, St Mary's, Isles of Scilly.

Proposal: Installation of electric vehicle charging point and creation of electric vehicle charging bays.

Comments: Raised concerns regarding the loss of permanent parking spaces.

Each proposed parking space length totals 4.8m (15.74ft) with two charging points (no measurements provided) separating them, given the overall length of the proposal initial thoughts are the loss of 3 conventional parking spaces. Concerns also raised regarding the width of the proposed bays (no measurement provided but would assume 2.4m-7.87ft) narrowing highway access to Sally Port, The Garrison and Jerusalem Terrace.

Site: Land at Parsons Field, St Mary's, Isles of Scilly.

Proposal: Installation of electric vehicle charging points and creation of electric vehicle charging bays.

Comments: Raised concerns regarding the loss of permanent parking spaces. With the proposed parking bays protruding 4.8m (15.74ft) in length access/restrictions to Sally Port and other parking bays are a concern.

Proposal: Installation of three electric vehicle charging points serving two parking bays for a car share scheme and two parking bays for general use charging.

Comments: Raised concerns regarding the loss of permanent parking spaces

The proposed shows three bays, including charging points, totalling a length of 6.2m (20.34ft) raising concerns regarding access into the car park and turning/reversing of other car park users.

Comments: Installation would be better suited within the grassed area 20/30metres to the north, allowing access to agricultural fields, residential parking and vehicle turning.

Proposal: Installation of four bay solar canopy and four electric vehicle charging points for a car-share scheme as an alternative to application P/20/028/FUL (Two bay proposal).

Comments: Concerns raised regarding restricting access to carpenter's workshop double doors whilst offloading large items, access to the Emergency Planning garage and available remaining working space required to service and maintain Moorwell sewerage station (servicing Jacksons Hill, Sylvester's Lane, Pilots Retreat and the Industrial Estate).
