



















Existing North East Elevation




Proposed 300mm Granite Finish to Exterior Wall of Workshop and Garage to include Proposed Amended Plan Amended Roof Details.


Proposed Finished Floor Level to be Lowered by 450mm to Current Garage Floor Level to include lowered Window and Door Details.
