## **Blockhouse Cottages, Tresco**

On Tresco, there is a shortage of large, high quality rental properties that cater for families and bigger groups. Changing tourism patterns have created a demand for this type of accommodation. The proposed building would enable the estate to provide a form of accommodation that does not currently exist on the island; a single building that can cater for large groups and/or specialist activities in one self-catered complex with dedicated staff. The proposed building would provide the opportunity for specialist expert led holidays; such holidays help to extend tourism into the shoulder periods. Alternatively, the new building would also enable several groups, families, or generations to stay together in a single property.

The proposals form an important part of the Tresco Estate's wider plans for the ongoing investment in improved accommodation for visitors to the Island. Flexibility and diversification of accommodation is important to the ongoing development of the guest experience and extends the holiday season.

The extremely poor condition of the existing cottages that the new building would replace has meant they have been used as the last choice accommodation for seasonal island workers. They are not let as holiday accommodation. It is not economically viable to repair these cottages, as is confirmed in the condition survey submitted in support of the application.

This application should be considered alongside a concurrent application that proposes the provision of 8 no. units of quality staff accommodation to be erected at New Grimsby that will replace and supplement the worker accommodation that is, on occasion, provided at Blockhouse Cottages.
