Site Description and Proposed Development

Moonrakers is a residential property split into a number self-contained flats used as either holiday letting flats or some being occupied as permanent units of residential accommodation. Flat 1 is used for holiday letting purposes.

The whole Moonrakers property backs on to the Garrison Wall (LB/SM) at the top of Garrison Lane. It is a mid-century dormer bungalow that has accommodation in the roofspace. It is a white render property with a shingle roof and a mix upvc and aluminium window and doors.

The proposed development is principally the replacement of double glazed aluminium windows with white UPVC windows with minor changes to the layout and style of the opening lights. There are windows on the principle front/east elevation looking out over Hugh Town, the north/side elevation towards Garrison Hill and the west/rear elevation backing up to the Garrison wall.

The proposal includes a slight enlargement of the northern most window on the principle east elevation of the building to match the depth of the equivalent window in the flat at the south end. Also, narrowing of the window to one of the bedrooms on the rear/west elevation to enable a larger opening light for an additional means of fire escape.

Relevant Planning History:

Planning history starts in 1956 when an application for the erection of a bungalow with attic rooms to be completed in the future and a temporary hut for use until completion of the bungalow (P0024) was approved. In 1961 an application for an extension to the guesthouse (P0328) was approved. In 1965 an application for garage (P0588) was approved. In 1969 an application for a further extension (P0857) was REFUSED. This was followed up by a further application for an extension (P0869) which was approved. In 1975 an application to convert the guesthouse to 6 self-contained flats (P1416) was REFUSED. Later in the same year a further application to split it into 6 flats (P1433) was approved. In 1985 an application to remove conditions (P2364) was approved. Later in 1986 an application for a kitchen extension (P2440) was approved. In 2016 an application to install two dormer windows (P/16/049/FUL) was approved. In 2019 an application to replace 3 aluminium windows with white UPVC and the relocation of an additional window (P/19/066/HH) was approved in Flat 6.
