Please find below SWW response in relation to this planning application.

In relation to a connection to the drinking water network South West Water is able to support an individual connection to the proposed new pod. As this is a new supply it will be a metered supply, and our metered tariffs will apply. The applicant should liaise directly with South West Water regarding the detail of this connection. The connection point will be the 2 inch public water main located to the south west of the site.

## **Asset Protection**

Please find enclosed a plan showing the approximate location of a public communication pipe in the vicinity. Please note that no development will be permitted within 3 metres of the pipe, and ground cover should not be substantially altered.

Should the development encroach on the 3 metre easement, the pipe will need to be diverted at the expense of the applicant. The applicant/agent is advised to contact the Developer Services Planning Team to discuss the matter further.

If further assistance is required to establish the exact location of the water main, the applicant/agent should call our Services helpline on 0344 346 2020.

We note that foul flows will be handled via a private septic tank and the surface water is to be discharged to a soakaway, as private SWW have no comments to make.

As part of South West Water's strategy to improve the drinking water and waste water infrastructure on the islands an investment programme has been developed which will be focused on achieving a reliable wastewater service including being able to cope with extreme conditions, protecting the environment and providing long term benefits to the community with the Company committed to support the necessary improvements in water and wastewater services on the islands so that services are in line with standards on mainland UK by 2025 or 2030 in the case of Tresco. This includes the ability to provide new water and sewer connections to the network and therefore it is recommended that the applicant liaises directly with the Company to discuss the potential of connections to public assets.
