




WEEE

Condition 2.3.7 of your permit, requires WEEE to be stored in compliance with Annex VIII of the WEEE Directive. This includes being stored on an impermeable surface with a weatherproof covering.

As the WEEE waste was stored in open cages or bays, I am scoring you a CCS3 under B4 Containment of Stored Materials.

On site we spoke about the covering you intend to install over the small container area (where the TVs, monitors and small appliances were stored). You will also need to consider improvements to the WEEE concrete bay storage area. If the bay cannot be covered, a sealed skip or shipping container may provide weatherproof storage for the meantime.
