Just so those who don't know can understand the ground/roof and foul water catchment for the Porthloo area this application covers.

All ground/roof water travels via ponds and leats eventually to the beach at Old Town.

All foul water has to be accommodated via septic waste systems, as there is not a mains in the area. The mains system does not start until Bay View Terrace at Sandybanks/Porthmellon area.

So I presume any application within this area would have to meet the EA requirements for water courses and sewerage treatment.
