Following the erection of the roof structure, it became apparent that the guest decked area was going to be too small & of little use. The lean to replacement is of less bulk and consumes less material.

The external finish has also been reconsidered and it is thought more appropriate to use a composite vertical cladding (recycled plastic & timber) rather than a cement render. This will be easier to maintain and have less environmental impact.
