Site Description and Proposed Development

This is an application to amend the approved plans for planning permission P/22/041/FUL granted on 7th September 2023. The planning permission is to construct a single storey side extension for the purposes of boat storage which included a roof terrace above for the upper floor flat. The extension is located on the north east facing elevation along Moorwell Lane and at the foot of Jacksons Hill.


The extension approved is conditioned to be retained for the purposes of boat and ancillary residential storage in connection with and management of the attached two residential properties known as The Tides (Spring Tide and Neep Tide), Jacksons Hill and shall not be converted to habitable accommodation.

Due to the slope of the site, the floor level of the garage is set slightly lower than the first floor level of the dwelling. There is no proposed access from the extension at lower ground floor level. The extension is attached to the side of the existing house, extending out by 3.2m with a depth of 8.5m. It is under construction at the time of this application to amend the approved plans which will see the footprint remain the same and the following changes proposed:

- Replacement of hipped roof with a mono-pitched roof removing the flat roof area accommodating the balcony.
- Patio doors no longer installed for balcony existing window retained.
- Mono pitched roof would be inset with a small leaded flat area to accommodate the existing first floor window which is set below the top of the roof.
- Introduction of 2 no. rooflights


- Raise overall roof height from 3.81m to 4.05m, eaves height to remain at 3.8m
- Replacement of painted rendered finish with vertical composite cladding REQUESTING CLARIFICATION OF COLOUR/SPEC

The application also seeks to remove condition 5 of planning permission P/22/041/FUL which required the submission of a site waste management plan by way of submitting the SWMP.



LOWER GROUND FLOOR PLAN APPROVED



Reason: For the clarity and avoidance of doubt and in the interests of the character and appearance of the Conservation Area, Area of Outstanding Natural Beauty and Heritage Coast in accordance with Policies OE1 and OE7 of the Isles of Scilly Local Plan (2015-2030).

Removal of pre-commencement condition C5 from planning permission P/22/041/FUL:

C5 Prior to the commencement of the development, hereby approved, a scheme including details of the sources of all building materials and the means/location of disposal of all demolition material and all waste arising from building works, including excess material from excavations, shall be submitted to and agreed in writing with the Planning Authority. The development shall thereafter proceed in strict accordance with the approved scheme only.

Reason: This is a pre-commencement condition that requires details that were not submitted as part of the application but are required to fully understand the impact upon landscape and management and minimisation of waste in accordance with the waste hierarchy, to be submitted and agreed by the Local Planning Authority. This is to ensure those characteristics which contribute to the status of the Isles of Scilly as a Conservation Area, Area of Outstanding Natural Beauty and Heritage Coast are not eroded by uncontrolled mineral extraction or the tipping of waste. In accordance with the requirements of Policies SS2(2) and OE5 of the Isles of Scilly Local Plan (2015 - 2030).
