## (Comments)

Thank you for consulting us on this application for the amended scheme to the Grade II Listed Town Hall (NHL 1219066), the rear of Parade Cottage (NHL 1141192) and its outbuilding (NHL 1291695).

We have consulted the updated Heritage Statement (Nick Collins September 2023) and Design and Access Statement (Purcell September 2023).

Based on the amended evidence, and similar to our advice on the original scheme (P/23/047/COU & P/23/048/LBC), in this instance, we consider it unlikely that significant historic building fabric and buried archaeological remains will be disturbed by the proposed redevelopment of the building and the adjacent site. Therefore, no historic building or archaeological mitigation is required, and no condition is sought.
