We commenced excavation of the foundation for the staff dwelling in 2022 and therefore a material start was made; however due to new flood risk information from the EA, we have paused work and are developing a new application to construct the staff dwelling in an alternative location on the site, outside of the risk zone. This has represented an unexpected delay to construction.

We would like the Condition to be changed such that the temporary chance in land use is valid for seven years rather than the current four specified in the Condition. This would allow additional time for us to use the yurt as a temporary dwelling in order to allow us to apply for a revised permission and construct the staff dwelling.
