Proposal: Demolition of existing building and construction of new single storey building providing 11 staff accommodation units with shared facilities.

Asset Protection

Please find enclosed a plan showing the approximate location of the public 100mm sewers in the vicinity. Please note that no development will be permitted within <mark>3 metres</mark> of the sewers, and ground cover should not be substantially altered.

Should the development encroach on the <u>3 metre</u> easement, the sewers will need to be diverted at the expense of the applicant.

Foul


South West Water is able to support foul only connections to the proposed 11 staff accommodation units and shared facilities. The applicant should liaise directly with South West Water regarding the detail of this connection. Capacity within the foul sewerage system is currently restricted and therefore individual connections are considered on a case by case basis. Any connection to the sewerage system will therefore be subject to the agreement of SWW in respect of both the timing and point of connection.

Surface water is proposed to discharge to a watercourse therefore South West Water do not have any comments to make on this.

As part of South West Water's strategy to improve the drinking water and waste water infrastructure on the islands an investment programme has been developed which will be focused on achieving a reliable wastewater service including being able to cope with extreme conditions, protecting the environment and providing long term benefits to the community with the Company committed to support the necessary improvements in water and wastewater services on the islands so that services are in line with standards on mainland UK by 2025 or 2030 in the case of Tresco. This includes the ability to provide new water and sewer connections to the network and therefore it is recommended that the applicant liaises directly with the Company to discuss the potential of connections to public assets.
