The permission is not for change of use and as it is a temporary application we believe there is no loss of bio diversity as it would be reverted at the end of the 6 month period so de minimus by Sept 25. The NIA of 24 pods is 193sqm and there is an exemption from BNG for under 200sqm, so 24 pods that would suffice as an exemption. Areas of human activity will be restricted to the service paths and the legs of the cabins, which will be placed on timber pads to reduce damage to the ground.
