I write in response to your application received at this office on 9th June 2022 in relation to the discharge of the above conditions for the outline approval for 12 Self-Build Homes at this site in Old Town, St Mary's.

Conditions that are Fully Discharged

I can confirm that the information submitted has been considered acceptable, with respect to conditions:

- C6 (Implementation of FRA and Drainage Strategy)
- C12 (Historic Landscape: Detailed and Targeted Trial Trenching)
- C13 (Submission of Written Scheme of Investigation)
- C14 (Construction Environment Management Plan)
- C15 (Submission of Ground Levels)

The following conditions remain outstanding and will require discharging as part of the Reserved Matters applications:

- C17 (Sustainable Design Measures)
- C18 (Site Waste Management Plan)

The following Conditions are **compliance only**:

- C7 (Layout of Car Parking before Occupation)
- C8 (Layout of New Junction)

The Following Conditions are **partially discharged** and will require further compliance as part of the post-completion of the project:

- C16 (Protected Species Enhancement Measures)
- C19 (Biodiversity Enhancing Landscaping Scheme)

In terms of the installation of bat and bird boxes and any other protected species enhancement measures, as per condition C16 then plot specific measures will need to be submitted as part of the Reserved Matters and will need to be in place before the occupation of each dwelling. Condition C19 will not be fully discharged until the full sitewide biodiversity enhancing landscaping have been completed. Condition C19 requires the site-wide landscaping to take place once 50% of the site is built-out.
