Hi Lisa,

The client confirm that the manufacturer for the proposed windows is Sovereign Group Ltd.

They have advised that the preparation of the sample windows is taking slightly longer than anticipated, as they wish to ensure that the samples reflect a high standard of quality and appropriately address the heritage sensitivities of the Conservation Area.

In the meantime, the applicant has provided a list of recent approvals and an appeal decision (detailed below and attached) where the replacement of timber windows with UPVC has been accepted in Conservation Areas including locations with similar considerations such as overlooking and setting. These examples demonstrate that comparable proposals have been supported by other Planning Authorities.

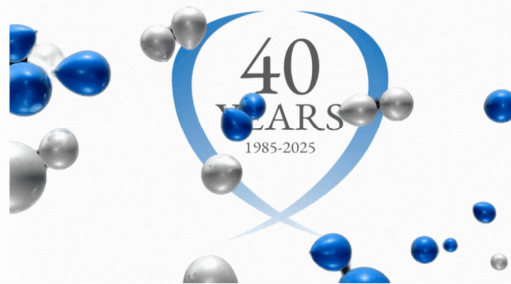

Thank you again for providing additional clarity on this.

Just a quick update regarding the window proposals. Following an the client's internal meeting, the client's window manufacturer are producing a mock-up of the proposed window so that they can provide a physical example or photographs for your review.

The sample will be 600 x 1000mm, white, vertical slider with horns, featuring a 28mm duplex unit with 21mm chamfered simplicity Georgian bars. It's due for completion on 27th October, so it is expected early next week.

Once it's ready, we'll arrange to send through photos or, if helpful, ship the sample to you for inspection in person.

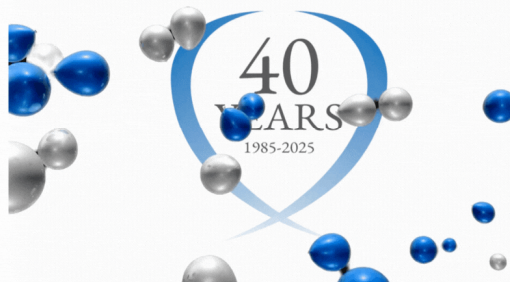

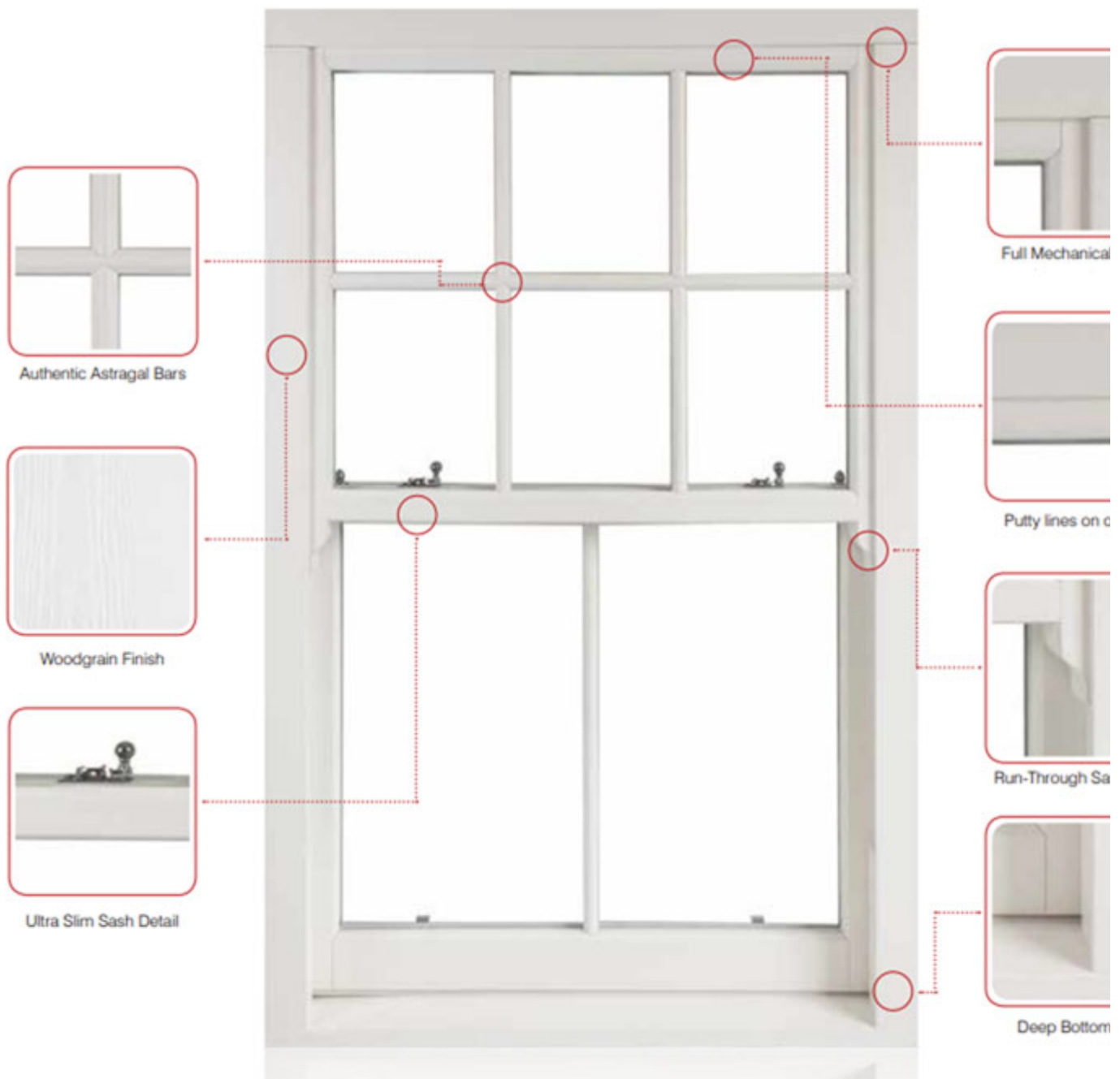
Thanks for the quick response. I had picked up on that. But what I would stress is that Under NPPF Paragraphs 194–196, decision-makers must consider the significance of the heritage asset; the impact of the proposal on that significance and identify and justify any harm that arises, including consideration of less harmful alternatives.

While the statement argues that Normandy House is not a designated or non-designated heritage asset, it is still within a Conservation Area, which is a designated heritage asset under the NPPF. We removed permitted development rights to change windows, to ensure replacements were not going to give rise to harm. Removing traditional timber windows and replacing these with a upvc alternative, without providing clearly detailed plans, does have the potential to give rise to harm, in my view, which could be apparent at greater distance (not just at close range), because of the chunkier frames/glazing bar details. The proposal therefore, does not clearly assess how the proposal preserves or enhances the character or appearance of the Conservation Area (as required by Section 72 of the 1990 Act). There is no evidence that less harmful alternatives (e.g. slimline double glazing in timber frames) were considered or ruled out.

I consider there does need to be a balancing of the harm/benefits under Paragraph 202 (where less than substantial harm must be weighed against public benefits). I think less than substantial harm could be concluded if you have provided clear details of the specific heritage. Without the details of the proposed window manufacturer, it is not possible to conclude no harm. If you can address these issues and provide details of the heritage specific products chosen, then I think there is the potential to accept the proposal.

I hope that helps. Example below to demonstrate there are products that do make claims of ‘appropriate’ in a conservation area.

Hi Lisa,

Based on the additional information I'm not persuaded that the materials proposed for the windows are acceptable, particularly in the principal elevation.





In terms of examples, I didn't specifically mean from Scilly, just if you have used a particular upvc brand/product successfully on a period building in a conservation area elsewhere, for example. If a local authority has accepted the particular product. (I'm not sure you specify whether this is a particular 'heritage' specialist product)

The proposal involves replacing traditional timber sash windows on a period granite building within a conservation area with uPVC equivalents. The stated justification is to help achieve SAP rating C by 2030, in line with government energy efficiency targets.

There are two key planning considerations:

1. The impact on the character and appearance of the building and wider conservation area.
2. The sustainability of the property.

I'm concerned that the current submission does not adequately demonstrate that the proposal would preserve the character of the conservation area. This is a prominent building that contributes positively to the local landscape, and it is critical that any replacement windows either are or convincingly appear as traditional timber sash windows.

No specification or sample of the proposed uPVC windows has been provided, making it difficult to assess their visual impact. While previous approvals for uPVC have been referenced, each application is determined on its own merits. The replacement of timber with uPVC may therefore fail to preserve or enhance the area's character, contrary to Section 72 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

Regarding energy efficiency, while improving SAP ratings aligns with national policy (e.g. NPPF para 152), this must be balanced against heritage protection (NPPF Chapter 16 and Policy OE7 of the Local Plan). It has not been demonstrated that less harmful alternatives—such as slimline double glazing in timber frames—have been considered.

I would suggest the following to support the application:

- Submit samples or manufacturer specifications showing the detailing, finish, and profile of the proposed uPVC windows.
- Provide a comparative visual assessment (e.g. photomontage or technical drawings) showing existing vs proposed.
- Consider timber alternatives with enhanced thermal performance (e.g. Accoya or engineered timber with double glazing).
- Include a heritage statement addressing how the proposal meets the statutory duty to preserve or enhance the conservation area.

I hope this is of assistance.

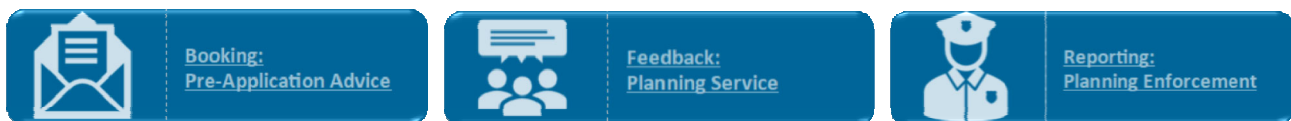

Further to my previous email and as discussed, please find attached the requested 1:20 scale drawings of the window details:

- Drawings SC36424_1 – 5 are based on Timber Casement and Vertical sliding sash “As Existing” The frame references are the same as your drawing 2070.09.NH.001
- Drawings SC36424_6 – 10 are based on a PVC Casement and Vertical slider “As Proposed” The frame references are the same as your drawing 2070.09.NH.001
- Drawings SC.36424_11 – 14 are sections for both Timber and PVC for your consideration for replacement

The window supplier has confirmed: *“Drawings 12 and 14 show the sections of the existing timber windows which would be replicated in the proposed frames so there would be no significant or noticeable changes.”*

In support of this application, I have also identified precedent approvals within the Isles of Scilly for timber-to-UPVC window replacements, including:

- [P/23/001/COU](#) Approved on 2 August 2023 - *Change of use of first floor to create one bedroom flat including alterations to fenestration and replacement of existing timber windows and doors with UPVC/composite units.*
- [P/20/069](#) – Approved on 23 October 2020 - *Replacement of existing timber windows with UPVC.*
- [P/17/073](#) – Approve on 20 November 2017 - *Replacement of existing white wooden frame windows with white UPVC double glazed windows.*
- [P/22/074/FUL](#) – Approved on 5 December 2022 - *Replacement of 4 single glazed timber windows and rear door/side panel with UPVC double glazed units.*

Many of these properties are in locations that are far more visually prominent from public roads than Normandy House. While Normandy House is a period property, it is neither listed nor designated as a heritage asset and has already been subject to various alterations and extensions. The existing windows and doors are not original, which further reduces the argument for strict conservation. For reference, I have attached photographs showing the current condition and character of the property.

I appreciate your request for examples specifically involving stone buildings but given the limitations of the Isles of Scilly planning register, it has not been possible to isolate these cases. Nevertheless, the approvals listed above demonstrate that UPVC has been accepted in sensitive and prominent locations across the islands. On this basis, there is a clear precedent for allowing UPVC at Normandy House, where the impact would be even less significant given its setting and existing character.

Finally, the proposed windows will be finished in off-white rather than bright white, ensuring the change is in material only, not in overall appearance.

For completeness, I had also requested an extension of time to allow sufficient opportunity to assess the plans given that the current deadline is Friday 26th September. As such, please let me know if you would like to confirm a short extension to ensure there is adequate time for full consideration.

I trust this information helps support the case, but please let me know if you need anything further.

Please also note that I will be on leave Thursday 25th September in the afternoon and all-day Friday 26th September. As such, I would be grateful if you could keep my colleagues Jon and Leonie copied in to ensure responses are picked up.

Thank you for your patience whilst we consider this application and my apologies for the delay. The case officer, Phillipa, has been considering the proposed replacement of the timber windows at this property, on behalf of the Council of the Isles of Scilly. However, as our arrangements with South Downs National Park will shortly conclude I am picking up some of the undetermined applications.

From a visit to the property and from assessing the wider landscape views of Normandy House, I am concerned that wholesale replacement of the timber windows will fail to preserve or enhance the character of the conservation area, of which we have a duty to ensure.

I know you have provided some of this information already to Phillipa, but as the proposed elevations do not show sufficient detail to ascertain the true change in appearance I would ask that you provide:

- 1:20 scale drawing of the window detail to include profiles
- Examples of other developments (anywhere in the UK) where the specific upvc window product proposed, has been successfully used in a conservation area, in place of timber windows.

Based on the information provided, currently, I am not satisfied that the changes proposed will preserve or enhance the character of the conservation area or be appropriate in this type of property. If you would like to provide further details, as requested above, I would suggest we agree an extension of time to allow the information to be provided and to allow time for further consideration of this proposal.

Alternatively, I will determine the application on the basis of the information submitted. If you could confirm as soon as possible.

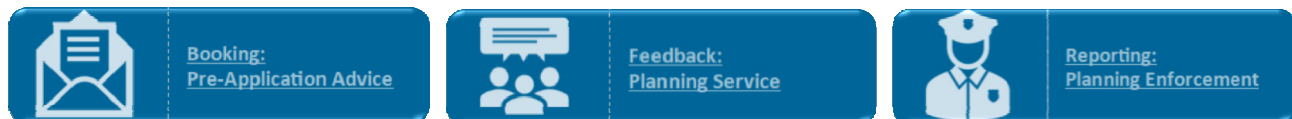
