The internal alteration works have been ongoing as the previous planning application was approved. During these internal works some of the previous works were deemed unacceptable so the works stopped & a structural engineers report requested on how to progress the works forward. Due to a time lapse from planning approval to the actual works being carried out it was advised to apply for a Law Development Certificate to the planned works were allowed to carry on. The attached pictures show how the works began & their current halted stage. Once the Lawful Development Certificate is approved, works will then commence again through to completion. The current state is not a listed building & will be upgraded due to the works into 3 self contained flats.
