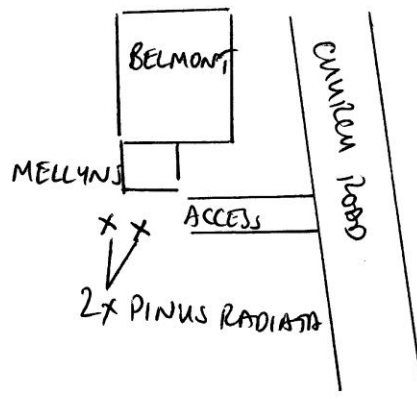

THIS APPLICATION CONCERNS 2x SEMI MATURE PINE TREES (PINUS RADIATA) SITUATED TO THE SOUTH EAST OF MELLYN'S. BOTH TREES APPEAR TO BE IN DECLINE AND ARE POTENTIALLY CAUSING RISK OF SERIOUS DAMAGE TO MELLYN'S AND ASSOCIATED AND SURROUNDING PROPERTIES.

THERE IS RECENT EVIDENCE OF ROOT-PLATE MOVEMENT WHICH IS UNDERSIANTABLY CAUSING CONCERN TO THE OWNERS OF THE ADJACENT PROPERTIES.

THE PLAN IS TO SECTIONALLY FELL AND REMOVE BOTH TREES.
