The two trees marked as 'DEAD' on accompanying plan No SP-HV-2A are the trees we would like to remove. In the short term we will lower the height by 20'-30' to make them safe.

NOTE. It does not take an expert to examine the state of the larger tree. The branches are bare at the top 10 ft and checking the trunk there are obvious parasitic growth climbing up the trunk up to over an inch/30mm diameter which are the source of the foliage showing on this tree. I will provide photographic evidence for your information!


