It has become clear that 1 year is not enough time for an effective pilot of a composting process to be carried out. 3 years represents sufficient time to successfully complete the pilot and collect the necessary data, while ensuring the change of use remains temporary and short-term to align with the Local Plan policies OE1 and OE7(5).
