## Description of Proposed Works

Please describe the proposed works

Replace whole roof of the original building with Listed Building compliant natural slate. Storm damage of the 8th January 2026 has left a large hole in the North West elevation of the roof facing the Mermaid Inn. Damage equals 30% of this elevation. Chimney stack also damaged in the storm and needs re-rendering and ties applied as a safety measure. White PVC guttering and down pipes will be replaced with the same. Renew fascia and soffit boards. Lead flashing will be replaced with new. Road closure, scaffolding approval, storage of materials sought with Highways of the Isles of Scilly. Waste materials to be disposed by Richard Hand Haulage in accordance with Local Authority rules. Lanhydrock Natural Slate will be used and will be dry fixed with nails and 316 stainless steel coated black clips to satisfy Listed Building requirements and the rigours of harsh weather conditions that occurred in recent years. Installation will be to BS5534. Works to be done in conjunction with Listed Building and planning consultants, Laurence Associates Ltd, and structural engineers, Form Consulting. Work to be done in accordance with Building Control Cornwall reference number BC26/00454/DTHBN. Ecology report has been done by James Falconbridge and interim Bat Survey completed in January 2024.

She also acknowledged that the method should be the most robust possible for the extreme weather location of Pier House. She acknowledged the frequency of storms and adverse weather conditions.
